Base Case Definition

 - District of Columbia
 - Anacostia Streetcar Phase 1
 - K Street Busway

 - Bus Enhancements: University Blvd and Views Mill Road
 - Corridor Cities Transitway: Shady Grove COMSAT
 - Purple Line: Bethesda New Carrollton
 - Virginia
 - Cherry Hill VRE Station
 - Columbia Pike Streetcar: Skyline Pentagon City
 - Crystal City/Potomac Yard Transitway
 - I-495 HOT Lane Transit Service
 - Potomac Yard Metro Station
 - Silver Line to Loudoun County
- Round 7.2a Land Use
- Increase train frequencies to maximum supported by infrastructure
- Reallocate Orange/Silver/Blue line frequencies to serve demand
- Extend Silver Line to Largo

- Revise Blue Line on 14th Street Bridge to Yellow Line 2

Capitol Street.








Metrorail: New Rosslyn Tunnel

New Blue Line along M Street, NW, Constitution Avenue and H St NW/NE




Relocated Silver Line with Ballston-Rosslyn Bypass

- 5. Orange Line to Centreville








Metrorail: Extensions

- 6. Silver Line to Leesburg








Metrorail: Interline Connections

- 3. Dulles to Vienna using connector 4 (Silver2)





 - CCPY to King Street








Priority Corridor Network (PCN)

- Based on networks developed for Priority Corridor Network (PCN) study
 - New routes coded as a limited stop BRT mode
 - Improved running times for existing background bus service as per PCN
- PCN Routes operated at 10minute peak and 15-minute offpeak frequency







Enhanced Priority Corridor Network

- Priority Corridor Network
- Montgomery BRT network
- NoVa BRT network
- Extend select PCN routes to core and new markets
- Interline PCN routes where possible
- Improve operations with off-board fare payment and express BRT
- Enhance commuter rail
 - Extend MARC to Crystal City
 - Extend VRE to Haymarket
 - Add bi-directional and off-peak service
